EVENT ENTRY/ RELEASES

In consideration of your allowing me, or my son, daughter, or ward to register, participate or observe baseball training and baseball games (“**Event(s)**”), and for other good and valuable consideration, receipt of which is hereby acknowledged, agree to release and forever discharge Philadelphia Baseball Training, LLC, and Philadelphia Baseball Tournaments, Newtown Edgmont Little League, Newtown Township and its affiliated companies, teams (e.g., “The Bell Ringers”), and their employees, shareholders and directors (hereinafter referred to as “PBT” and collectively, the “Releasees”) for myself, my son(s) or daughter(s) or ward(s), and heirs, representatives, executors, administrators, successors and assigns), from all actions, suits, debts, covenants, contracts, agreements, judgments, claims and demands whatsoever, in law or equity (collectively, “claims”), whether known or unknown to me, arising out of or in any way connected with my, or my son or daughter’s participation in any Event(s), and any bodily injury, death, economic or other loss based upon negligent, reckless or intentional conduct arising out of, or in the course of our participation in any Event conducted by PBT.

I realize that Baseball (and activities associated with baseball), is a physical activity that could be potentially hazardous and I, or my son and daughter should not participate unless medically able and in good condition. I, on behalf of myself and my child, therefore assume any or all risks associated with participating in, or observing any Event, including but not limited to excess physical exertion, falls, contact with other participants, the conditions of a facility, the stands or the field, any third party conduct, and my own observation of a baseball game or practice, all such risks being known and fully understood by me.

By the above, I understand that I am giving up all claims against the Releasees, or against any person acting on the Releasees’ behalf, or against any affiliated company, related to my participation in the event. Further, I agree that my release includes but is not limited to claims for bodily injury, death, sickness, impairment of economic opportunity, intentional infliction of emotional harm, or any other tort (legal wrong) based upon negligent, reckless or intentional conduct.

This waiver and release extends to all claims of every kind or nature whatsoever; foreseen or unforeseen, known or unknown. I also agree that PBT may use my or my child’s or ward’s name, picture, and or likeness in connection with all publicity about an Event and the results thereof.

WAIVER/RELEASE FOR COMMUNICABLE DISEASES, INCLUDING COVID-19

In consideration of being allowed to participate in any way in PBT’S baseball programs and related events and activities, the undersigned acknowledges, understands, and agrees that:

1. Participation in any Event includes possible exposure to and illness from infectious diseases including but not limited to MRSA, Influenza, and COVID-19. While particular efforts of PBT and personal discipline may reduce this risk, the risk of serious illness and death does exist.

2. ON BEHALF OF MYSELF AND MY CHILD/WARD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others and assume full responsibility for our participation.

3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards our protection against infectious diseases. If, however, I observe any unusual or significant hazard during my or my child’s/ward’s presence or participation, I will bring such to the attention of the nearest official immediately.

4. I, for myself and on behalf of my children, spouse, heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS PBT, its officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

5. **Parents or Guardians shall ensure that they check for any symptoms related to CoVid-19 or any other communicable disease, that their child or ward may have, that may affect any other participants in PBT’s Events. In that event please do not bring your child or ward to the Event.**

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP CERTAIN RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY ON BEHALF OF MYSELF AND MY CHILD OR WARD, WITHOUT ANY INDUCEMENT.
